

General Deposit Information

- Clark's Labrador Retrievers reserves the right to keep first pick of any litter.
- Puppies are picked in order that the deposit is received, for that specific litter. A deposit of \$500 is required to hold your pick. **Please contact us to confirm availability prior to sending a deposit.**
- All deposits are non-refundable and non-transferable. We take the commitment of receiving a deposit seriously, thus turning away other families or those interested in a specific pick from a specific litter. Likewise, we expect families placing a deposit to understand the seriousness of the decision, realizing the deposit is nonrefundable and non-transferable. We would encourage those with specific requirements of color, size or timing to wait until pups are on the ground and individual pups become available until placing a deposit.
- The balance is due at the time the puppy is 8 weeks of age. Puppies are expected to be picked up at 8 weeks of age, unless prior arrangements have been made. Balance may be paid with cash, money order, cashier's check; or by personal check if sent 10 days prior to puppy pick up.
- If puppy is not paid in full by 8 weeks of age, buyer understands the puppy will be relisted, and buyer will lose deposit.
- Puppies are sold on **limited AKC registration**, unless otherwise discussed.
